



Cricket Warranty

D & R Golf Cars, LLC hereby warrants that new CRICKET vehicles purchased from D & R Golf Cars, LLC will be free from defects in material and workmanship for the period of 3 yrs., subject to certain stated limitations. D & R Golf Cars, LLC is not responsible for any abuse, negligence, vandalism, acts of nature or delivery damage if buyer accepts delivery.

The Period of Warranty

All CRICKET vehicles shall have a warranty period of 3 years from the date customer takes possession, or upon verified delivery of vehicle to customer's designated delivery address. Batteries are warranted for 12 months.

During the Period of Warranty

D & R Golf Cars, LLC will, free of charge, repair or replace, at its option, any part adjudged defective by D & R Golf Cars, LLC during the warranty period due to faulty workmanship or material from the factory. Parts used in warranty repairs will be warranted for the balance of the product's warranty period. All parts replaced under warranty become property of D & R Golf Cars, LLC.

General Exclusions

Exclusions from this warranty shall include any failures caused by:

- a. Competition or racing use
- b. Installation of parts or accessories that are not qualitatively equivalent to genuine Cricket manufacturer parts or accessories
- c. Abnormal strain, neglect, or abuse
- d. Lack of proper maintenance
- e. Lack of charging batteries properly
- f. Accident or collision damage
- g. Modification to original parts
- h. Damage due to improper transportation
- i. Damage from improper use due to exceeding 10% grade incline or decline terrain.
- j. Damage from improper use in accordance with the Users/Owners Manual. Please read owner's manual.
- k. Damage from improper use of Brake, Freewheel, rear braking lever.
- l. Exceeding weight capacities as listed in owner's manual
- m. Cosmetic Deterioration, including color fading, cracking, peeling, rust or scratching.
- n. No labor warranty or transporting to and from an authorized service location.
- o. Shipping damage unless previously discussed with D & R Golf Cars, LLC. Must be notated on delivery bill of lading.
- p. Any part removed or disassembled unless previously discussed and/or authorized from D & R Golf Cars, LLCs.

Specific Exclusions

Exclusions from this warranty shall include parts replaced due to normal wear or routine maintenance or computer faults, such as upholstery, light bulbs, and brake shoes, tires, hubs, motors, transaxles, bearings, bushings and batteries. Batteries are on a 1 yr warranty if properly maintained per charger manual. Batteries must be brought to D & R Golf Cars, LLC for thorough computer diagnostic. If any or all stall warnings are present on computer diagnostic parts will not be covered.

The Customer's Responsibility

Under this limited warranty, the customer's responsibility shall be to:

- a. Operate and maintain the vehicle as specified in the appropriate owner's manual.
- b. Charge batteries as recommended by D & R Golf Cars, LLC. Batteries are to be left on charger if cart is not in use. Allow charger to maintain, balance and float battery levels. (See charger manual) If batteries are left off charger for more than 14 consecutive days, battery warranty is void.
- c. Give notice to D & R Golf Cars, LLC of any and all apparent defects within ten (10) days after discovery, and make the vehicle available at that time for inspection and repairs at D & R Golf Cars, LLC or an authorized service center.

Warranty Transfer

To transfer the warranty from the original purchaser to any subsequent purchaser(s), the vehicle must be inspected and registered for warranty by D & R Golf Cars, LLC In order for this warranty to remain in effect, this inspection and registration must take place within ten (10) days after transfer. (An inspection and registration fee will be charged for this service.)

Additional Warranty Information

D & R Golf Cars, LLC makes no other warranty of any kind, expressed or implied. All implied warranties of merchantability and fitness for a particular purpose which exceed the obligations and time limits stated in this warranty are hereby disclaimed by D & R Golf Cars, LLC. and herewith excluded from this warranty.
